B-METAXDG2	CZ_SOP_D06_09_001 (US EPA Method 200.7, ČSN EN ISO 11885) Determination of elements by atomic emission spectrometry with inductively coupled plasma and stoichiometric calculations of compounds concentration from measured values. Sample was homogenized and mineralized by acids and hydrogen peroxide prior to analysis.

If the UNICO-SUB code is stated in the method table, this only informs that the tests have been performed by a subcontractor and the results are given in an annex to the test report, including information on test accreditation.
